senior and subordinated debt, preferred and common equity, structured credit facilities, and fund-level capital formations across multiple industries.



Mr. Ragland brings a differentiated perspective to investment banking through his combined experience in capital markets, operations, and governance. He has participated in multiple M&A transactions, advised management teams on balance sheet optimization and recapitalizations, and served as a trusted intermediary between sponsors and capital providers. His work frequently involves aligning capital structures with operational realities and long-term strategic objectives.

Mr. Ragland is deeply engaged in institutional governance and nonprofit leadership. He currently serves as a trustee of St. Edward's University, where he participates in fiduciary oversight, institutional strategy, and long-term stewardship of the university. In addition, he has held board and committee leadership roles with organizations focused on education, community development, and industry advancement, including The Trail Conservancy and the American Association of Private Lenders, where he served in national leadership positions. His governance experience reflects a consistent focus on accountability, mission alignment, and long-term value creation.
