Dedicated to preserving the cultural and intellectual capital of the East, Charles is a longtime Board Member and the Finance Director of Gaudiya Vedanta Publications, an independent publishing house headquartered in California that has published more than 100 classics on Vedanta, yoga philosophy, and *bhakti* mysticism in multiple languages. Charles has established an endowment fund to ensure that each publication, once released, remains in print in perpetuity.

In pursuit of the Eastern aspiration of *seva*, selfless service, Charles takes a special interest in protecting and preserving spiritual heritage sites in India, as well as in supporting the education, development, and wellbeing of children from vulnerable communities in the United States and abroad. To that end, he has provided invaluable grassroots financial and strategic support for combatting the mass-hunger, loss of livelihood, and medical crisis caused by Covid-19 in India. In addition, Charles actively supports a number of local and international non-profits, including The Puente Project in California and Food for Life in India.

Charles received a B.S. in Business Administration (emphasis in Corporate Finance and International Business) and an M.B.A. (emphasis in Sustainable Business) from San Francisco State University. He holds Series 24 and 79 registrations from FINRA.

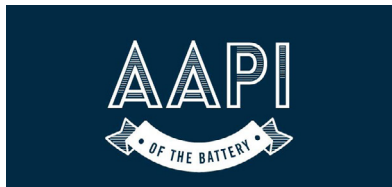
